DRIVERS EDUCATION APPLICATION/AGREEMENT

This document will serve as an agreement between AC Driving School LLC, and the student and the student's Guardian/parent(s).

- 1. Students must be at least 15 years of age by the 1st class to attend the course (WAC 308-108-120)
- 2. Students must complete 34 hours of classroom instruction including 4 hours of Drivers Zed simulator instruction, 5 hours behind the wheel driving, and 1 hour of observation.
- 3. Students must complete lessons and the overall course test with a score of 80% or higher. (WAC 308-108-120).
- 4. Parents must attend an orientation (1hour) prior to their students attending class or being issued a waiver to the DOL. WAC 308-108-150.
- 5. Tuition must be paid in full prior to the start of class unless mutually agreed upon with AC Driving School.
- 6. Students will not be allowed to be enrolled after the 3rd class.
- 7. Students may withdraw from class up to the 1st drive. A \$100 fee will be forfeited, and the remaining balance will be returned to the parents.
- 8. Legislation requires class instruction on Organ Donation (RCW 46.82.420)
- Missed class sessions must be made up in order to maintain the concurrent order of learning. If a student misses more than 3 classes, the student must retake drivers' education course and will need to pay tuition again.
- 10. Regulations governing the commercial driving school dictates that the time frame from the beginning of the class to the issuing certificate is not less than 30 days, and no more then 180 days. (WAC 308-108-120 (2d)
- 11. Students not completing within two weeks of the last day of class period may be required to retake the course.
- 12. A student can be removed from the course for behavior problems, cheating, graffiti, defacing class materials, coming to class intoxicated or under the influence of narcotics with no refund.
- 13. A student will be removed from class if the student is charged with any criminal offense including any criminal traffic offense (TMVWOP, Reckless driving, DUI, or road rage incident) and will be removed immediately without refund.
- 14. Use of tobacco products are prohibited within 500 feet of ACDS Classroom
- 15. Any equipment (cell phone) that distracts a student during class will be removed from that class.
- 16. Families agree to provide opportunities for the student to practice driving at home. Students must have 50 hours of total driving 10 hours at night prior to obtaining a Wa driver's license.
- 17. Drives must be cancelled prior to 24 hours, or the student will occur a \$30 cancellation fee.
- 18. Students will be charged a \$30 fee if they show up to a drive without a permit and must schedule another drive session.
- 19. Students are expected to wait 10 minutes from drive start time for the instructor to return from prior drive before leaving.
- 20. Students who show up intoxicated or drug impaired will not be allowed to drive and will be removed from the class without refund.
- 21. Students will be required to place their cell phones in the console of the car during the drive, including observation drives.

Families will be responsible for providing coverage for their vehicle and their permitted driver.

I agree to abide by the above conditions and guidelines. I realize that violations of these policies are grounds for dismissal from the course.
